

# Vybrané a důležité publikace k tématu veřejného zdraví odrážející se v Souborném katalogu ČR, tj. které jsou dostupné v tuzemských knihovnách

**Zpracováno v Oddělení vědeckých informací IPVZ pro potřeby Školy veřejného zdraví IPVZ.**

Publikace jsou dostupné minimálně v jedné knihovně v ČR, a tudíž získatelné k uživateli službou **MVS** (meziknihovní výpůjční služba), kterou poskytuje většina knihoven v ČR (lze zvolit v místě bydliště, odbornou knihovnu, také Národní lékařskou knihovnu ČR).

Služba je v podstatě dostupná každému, ale je založena na platbě za poštovné, pokud knihovna nevolí jiný způsob úhrady za uživatele. Některé dokumenty jsou i vzdáleně elektronicky dostupné po patřičné registraci do příslušné knihovny (např. do Národní knihovny ČR).

Výběr byl zohledněn časově (**od r. 2009**) a odhadem potenciálního zájmu ze strany uživatelů – zdravotníků. V podstatě jde tedy o komplexní seznam vybraných podstatných titulů k tematice veřejného zdraví.
